## Please describe how your home or business Internet connection supports or hinders your online world.

- At our home we do not have access to broadband options. We rely only on Verizon wireless hotspots that we purchase and loan from the library. Not only is this not a great long-term solution, it limits our ability to get work and homework done. It is not cost effective, and there are other amenities - not necessities that would be great to use but are not possible with our current set up such as using a router for devices, a wireless printer, security cameras, or even smart home features.
- 2. We don't have access to most internet providers at my house. It's nearly impossible to work from home and my daughter struggled to stay connected for school in the fall
- 3. Home: had to turn off land line as was not an acceptable connection or many times no connection. Now forced to hotspot from cell phone to use.
- 4. Connection is sporadic, some dropped which is frustrating. Many times have to search the premises to get enough bars.
- 5. Our internet is terrible and we are just yards off of highway 61. My kids were quarantined due to covid for 24 days and each day we would have to load up and sit in the local McDonald's parking lot because our interent wouldn't load their Google classrooms.
- 6. Slow very slow. Weather also plays a factor
- 7. My husband and I throughout COVID have worked remotely. We have three children that utilize remote learning, either through a high school or college. So with up to five people online at once our internet service and utilization can be strained. Lastly, both my and my husbands employers are moving to a remote work environment, so having stable and reliable service is paramount to us continuing to reside in pine county.
- 8. There are only 2 choices for internet and both are not very cheap. I have had issues with them both working well when I need them to for working from home. The speeeds are not what they are in large cities.
- 9. The Chamber is fortunate to have an office space with access to fiber in Downtown Pine City.
- 10. We use a jet pack in our home to use as a hot spot. It only allows us 15 gigs each month to use and that is used up with the first 4-5 days. For the rest of the month it is considered slow speed and things take a while to connect or it pauses making it almost Impossible.
- 11. I work from home so if my internet is lagging or down then I cannot do my job efficiently.
- 12. Home internet is touch and go, slow speeds. Often have to limit users at any given time.
- 13. 90% of the time we can't even stream on one device. We can't let our kids use the internet because it will be used up in two days. We can't even do conferences.

- 14. Business Internet We are fortunate to be part of a larger network that allows for fast-speed internet for our employees and students. However, when the pandemic hit, it presented challenges that we were not yet prepared for. Students returned home without the ability to properly connect and with no ability to come to campus, many had to withdraw from courses. Employees were not able to perform work at the speed at which they could on campus. As a large employer in our area, it is imperative that we have consistent connections throughout our county to ensure equitable access to jobs and education.
- 15. Our internet connection is slow and spotty. I work from home 100% and my husband does periodically. The lack of decent internet means it takes longer to complete our tasks and upload/download information. I have had many opportunities to grow my business via Zoom but was unable to because of the lack of consistent internet. With the current COVID issues regarding school, it is very concerning when our children are supposed to learn from home with poor internet. The assumption is that everyone has an internet connection, which is far from accurate.
- 16. We don't have the option for any high speed Internet at our house
- 17. We are underserved allowing me to attend meetings but nothing else can be running in our home
- 18. Our current internet connect supports everything we need it to do.
- 19. Hot spot that runs slower by the end of the he month, zooming is sketchy
- 20. We have no affordable options for broadband and cellular coverage is also poor

- 22. weak signal, dont always work
- 23. We have no internet at home unless we use our Hotspot on our phones. Pretty shameful and difficult to explain to our special needs son.
- 24. We are working to make as many of our resources available online as possible.
- 25. Not having internet greatly impacted my children's education this past year when schools went distance learning

- 27. I work from home and sometimes the internet is not fast enough especially when the grand children are working on homework.
- 28. Right now I have decent internet with Centurylink for a good price.
- 29. Very poor service, like we are in a dead zone. Sometimes we reception and other times nothing. There is fiber optic on both north/south roads.
- 30. We can not stream programs. We cannot attend meetings by Zoom using video without being dropped at least every 8 minutes. Our grandchildren can not do homework at our house because their websites will not load after 7:45 a.m. -8:10 p.m. On weekends and holidays when "lake people" are in our area we have .5 of a bar of service. Our son-in-law is on 24 hour call. When he visits us he has not received important calls until he heads home days later. Ordering items on line is like a crap shoot. Sometimes orders go through and other times they do not. I can not FaceTime with grandkids. I can not use What's Up video chat app with my relative in Germany.

- 31. The only adequate connection we have at our home is through a Verizon hotspot. It is better than other options we have tried, but would love something better.
- 32. Within the home, during distance learning, it became difficult for my own children to log into their homework at the same time along with myself. As a teacher, many students do not have access to the internet within the home and hot spots were not a reliable solution.
- 33. The lack of internet/cell phone connections in our area has impacted my children's schooling and is a deterrent for community expansion.
- 34. Expensive and not real effective
- 35. I do not live in Pine County and have a a 100 Mbps connection at home.
- 36. At my home, I pay for 12 Mbps and rarely get that speed, but this is the only service available to me. Fixed wireless is unavailable. Satellite is not affordable. Cellular service at my home can go in and out so hotspots don't work very well.
- 37. I have poor access to high speed internet, which hinders zoom calls as the satellite internet I have now is extremely bad.
- 38. In addition to personal use, I run a small business from my home. We have satellite internet service because it is the only service available right now that is at all dependable in our area. In order to work from home, I need fast dependable internet access and service.
- 39. Slow connection when working from home, very challenging when kids are home at same time due to distance learning.
- 40. I have limited internet service (slow speed) with a phone line modem. If I have two or more devices on the system, upload and download speed is terrible. The service is constantly interuppted and is not reliable.
- 41. I have slow and expensive satellite internet service from ViaSat. It is just acceptable for home use with minimal streaming. My home is my backup office location as Covid showed we needed to be able to operate remotely to provide customer service for our many clients. At ~ \$167/mo this is the top tier available to me and is too expensive for the speed and bandwidth provided. It is not uncommon to have a Zoom meeting interrupted or a video buffering. This puts me at a competitive disadvantage to other financial advisors who may live where they have more reliable wired service as well as reasonable choices.
- 42. As a school system having internet is essential to the function of our school. During and after the pandemic it is essential for our students to have internet at home.
- 43. I have SCI cable internet, good service
- 44. With kids in distance learning again at Hinckley high school it's a must and you never know when they will start. We found out at 7 pm the night before via Facebook. No call. Also I am a PCA so to do my timesheets and communication with the teams.
- 45. Home internet (via satellite) is expensive and too slow to stream so it also limits our TV service options, which is also expensive then as well. Being satellite, we also can lose connection if really windy, stormy, or heavy snows.
- 46. I have satellite and the speed get reduced if I use over 150 gigs. Hard when I get through have the month before the speed slows way down. It was very difficult when my kids were in distance learning last year.

- 47. We only have access to limited DSL. Our location exceeds the recommended distance for a stable connection. This constrains our ability to reliably use the internet for video communication and many times simply accessing email.
- 48. Being a remote employee it is a necessity to have sufficient internet. I only see this becoming a higher need as more employees are allowed to work from home.
- 49. We have no option for high speed internet at our home address. Our children cannot complete online school work from home.
- 50. We have nearly no options for internet service at our home. We currently use HughesNet satellite service. Our download speed is usually around 1-2 mbps and upload is about 1 mbps. This prevents us from working from home when needed, video conferencing is impossible, streaming video is impossible, and our kids have a very hard time getting any schoolwork done when needed at home.
- 51. It hinders us as we don't have any options at our home. My children are unable to do school work at home! We can not print, watch any tv (except if we have satellite which is outrageous), or communicate with family in other states.
- 52. As the library system that serves Pine County, we hear regularly from patrons who have trouble accessing broadband. Our hotspot loan program has been a help, but it's not enough.
- 53. We do telehealth therapy sessions. I am able to get service in town; however, I was not able to work from home when COVID happened because I was not able to find an adequate service provider for my area. I tried many options from mobile hot spots to satellite, none of them were a solution. Some of them were able to provide some service, but not enough for me to provide services online, and others charged per mg, which became so expensive that it was a hinderance. In addition to my own difficulties, we have had many people in Pine County that could benefit from our services if they had access to good internet.
- 54. Slow internet makes uploading information to my website a slow and tedious process. Ads have been late coming off due to internet being down. Stories require internet communication.
- 55. I am fortunate to have SciCable internet access at my home as I live right in Willow River. Our School also has reliable internet access, however many of our students do not have that access at their homes.
- 56. It works pretty well, most of the time. It is adequate for my uses.
- 57. Our internet is slow, unreliable and expensive.

## Please share your thoughts on how Lincoln County is positioned to provide the high-quality workforce.

- 2. I believe they aren't with lack of internet at this time.
- 3. Seems to be plenty of available workforce. The labor market has become competitive causing costs to rise.
- 4. Workers are in short supply at this time. Quality workers are produced when pay is fair and training to be effective workers is provided.

Pine County will see exponential growth as more and more individuals decide to move north; as well as the shift in culture where younger adults want to stay closer to home with the uncertainty of the world around them. Speaking from recruiting experience, we are seeing phenomenal pools of candidates from both local and commutable distances. During the interview process, candidates want to relocate to this area but express concern with the lack of local business (options), housing, and internet service. - 30. The need is present in our ranking as almost the worse in the State. The northern communities have three of the top wire plowing services in the Midwest. Contractor are steadily building new homes. Finlayson has added 74 new mailbox holders in 2 years. With a decent wage, the workforce would respond favorably.
- 31. With free 2-year tuition to Pine Technical & Community College for all Pine County seniors, the county is poised to have an exceptional, highly trained workforce of young people in short order. However, if we do not have the jobs here, they will leave.
- 32. Located between the TC and Duluth we have the ability to draw companies along the interstate as well as individuals who can work from home.

- 35. Partnerships with Pine Technical and Community College and dedicated public leadership at the school districts.
- 36. Pine County is well positioned, especially with the college scholarship initiative with the Frandsen Foundation, Pine Technical & Community College and, Pine County's ARPA funding.

- 38. Pine County is geographically in a great position to provide a high quality work force. We have a significant portion of our population that has relocated here because the location is rural, but midway between two urban centers (Minneapolis/St. Paul, and Duluth). Those people who grew up here and have chosen to stay have limited choices for careers and jobs. Excellent internet would give residents more employment choices.
- 39. In this virtual world we've shifted to, Pine County is not equipped to provide the internet needs to support remote workers.
- 40. I have fiber optic cable running through my front yard, but there is not a company that is currently using it. Pine County can help find a company that would be willing to tap into this service and offer reliable broadband.
- 41. With a major interstate running the length of the county, located in a major travel corridor, Pine County is positioned to diversify and provide more high quality businesses and jobs if the broadband resource could approximate the road system in speed, traffic and quality. Lack of accessible, reasonably price, high-speed internet to all areas of the county is keeping it a poor rural county. Covid showed the need for remote teaching, medicine, event business meetings and without that infrastructure, Pine County residents and businesses are at a significant disadvantage and consigned to the internet backwaters.
- 42. Pine County is a great position to provide a high quality workforce because there is a will to make Pine County a place business want to be and workers want to live. We need fast reliable internet in each and every home to make this happen.

- 43. I know there are areas within the county that needs some help. I know the commissioners are working hard to fix that
- 44. There is some great places to work however there very small staffed, but we could use some more great quality ones and larger ones.
- 45. We have a local college with IT programs and courses as well as construction trades to provide highly skilled workforce.
- 46. And I'm sure if Pine county had better fiber optic more people would relocate here.
- 47. We are not the only families living in rural areas on the edge of cell phone and internet access if at all. This is a common issue for a majority of the county population outside larger population areas.
- 48. I'm unsure if Pine County currently has the ability in all areas to support. The workforce is changing to allow more remote positions. If I did not have internet access this location would no longer be a place I could reside.
- 49. In town the positioning is good, however, for those working in the rural areas the positioning is terrible.
- 50. I'm not sure.
- 51. We are located literally in between two major cities and we have nothing here to bring people in!
- 52. The library wants to be part, and can be part, of helping to educate and train the county's workforce.
- 53. Pine county could become a high commerce area if we were able to provide the resources to people wanting to set up business here.
- 54. Having a college in the county means the area can provide an educated workforce.
- 55. Pine County has a high school population of hard workers. They are our future and we have the task of training them for their future careers in the hope that they will choose to settle locally.
- 56. Within the cities, I think things are fairly good, Internet-wise. But outside, it is often not adequate for any sort of business or school use. Or entertainment.
- 57. My concern is for the schools and school children who have to home school .

How do you see unequal access [digital equity] to technology and the internet creating a divide in Lincoln County? If you have an example either from your family or someone you know, please share it.

- 1. Geographic area that one lives is likely the largest factor, followed by affordability for those who do have access.
- If my children were moved to distance learning it would be very difficult for them to get quality education. Often they had to wait until I got home to use my personal hotspot. I also am forced to go into the office on days I could work from home because we don't have strong enough connectivity to do zooms/google meets
- 3. I, personally, was not able to sell some real estate in Partridge Township when I had a willing buyer who found out how bad the internet access was. I believe this happens more often than we know.
- 4. Those without good connection or no access, is especially difficult for families with children in school, as they can't use resources available to families with higher incomes. Many people are below the poverty level in Pine and Kanabec counties and can't afford hook up to fiber optic cable, even if it goes right by their homes. Pine and Kanabec counties rank at the bottom of cellular service in MN. This is similar to when rural areas got electricity far behind the towns and cities many years ago.

- 11. Having access to the internet opens up a host of opportunities whether they be employment based or community based.
- 12. The cost for high speed internet, when available, is very expensive and not proportional to the income of our community members. Even when given a hotspot from the school for distance learning last year, when one of my kids would use the microwave, the others would loose connection.
- 13. People who live in town have decent service but those of us who rely on satellite are doomed if we go back to distance learning
- 14. Specifically, we see this from a business perspective in our student population. Students are unable to connect in rural areas and since most of them are home-bound for multiple reasons, they are unable to participate in education. While others who have the ability to drive to school or live close enough to have the ability to connect to the internet for a reasonable price, have the ability to better their futures by attending school in person or online.
- 15. My business is relationship based. With the introduction of COVID, many in my field were able to seamlessly transition to an online business format. Without a solid connection, I cannot rely on Zoom or other live-streaming options to run my business. This puts me and my business at a distinct disadvantage.
- 16. Remote work and remote learning are extremely difficult for families that live out of city limits. There is the option of star link but it is incredibly expensive
- 17. If you are in a city or highly populated areas you have a better chance of having service. Most of Pine is in outer areas and suffering
- 18. I work with struggling teens here in Pine County and when all the schools were having to do online school last year so many of our teens struggled. Either they didn't have internet at their house, or if they did it wasn't nearly fast enough to do everything they needed to do for school and Zoom calls.

- 22. we can only do the best that we can at this time, the future will be better
- 23. I think it creates a divide because some families have to go sit in a parking lot in order to do school work, work or other things that need to be done, while others have access to internet because they live "in town". Not very fair to residents who live in the more rural areas.
- 24. I see people using the resources at the Public library to access resources needed for daily living, such as job and educational opportunities, interacting with government agencies, etc.
- 25. Outlying areas such as Duxbury don't have adequate internet services and often lack cellphone service as well.

- 27. I have my grand children living with me and have to micromanage internet usage so that I can do my job.
- 28. Poor people without internet or very poor internet and rural people with only expensive satellite internet are underserved.
- 29. There are dead zones east of Rock Creek the kids can't do school online and can't do business
- 30. Personally, if I want to upload photos to make a book, add to a training file...I drive to Pine City or North Branch to our daughters to do that. She has 4 bars of service and 5G is available.
- 31. This past year made it very clear that those in dead zones not covered by cable or radio internet via Genesis Wireless are going to be several steps behind in terms of speed and reliability.
- 32. During distance learning, the lack of internet only created a larger educational gap in the already low-income households. There are numerous examples of students driving from Markeville over the WI border to access the internet or driving 45 minutes to park in the EC parking lot.
- 33. I am town chair of New Dosey and have had several discussions with individuals which would like to move to the area. They have expressed this is not a viable option due to the lack of internet providers/connectivity. Their family cannot not work, complete schooling and maintain extended family relationships due to the insufficient internet in the area.
- 34. As an educator, we see great discrepancies not only due to economic factors, but due to location as well. It causes great issue for some students.
- 35. The biggest impediment to pine county employees working from home is lack of internet service.
- 36. I see the divide between the cities (who are well connected) and the townships, who are not as connected due to lack of density.
- 37. During the pandemic I, my younger siblings didn't have access to high speed internet at home. Therefore, making it hard for them to do school work.
- 38. There are areas within the county, especially in the southern part, that have much better internet access. The northern part of the county, and east and west parts away from the I-35 corridor have much poorer service and very limited options.
- 39. Rural northern Pine County has terrible internet speeds.
- 40. As an educator, I personnally witnessed inequity in learning due to lack of internet. Families with limited or no internet struggled to meet with teachers remotely, upload or download homework, and even conduct necessary research.
- 41. The people in town next to hard-wired internet are at a competitive and educational advantage. I know people who are able to run their businesses and family interests on the internet efficiently at a reasonable price with many choices. I have 2 choices - satellite and wifi. At my home Satellite is expensive and just acceptable, the WiFi option would not be. No option for cable or fibre-optic.
- 42. From a school perspective it is making equity issues worse between students and families. In other words, if my family has fast reliable internet I am getting a better education then my neighbor that doesn't. The quality of your education should depend on your zipcode.

- 43. As the CVSO I have knowledge of veterans in the northern part of the county that can't do basic VA required actions because of lack of internet
- 44. The internet is really bad at some locations and it is hard to do anything even on a phone.
- 45. Unequal access to technology is often due to affordability of access. A lack of access contributes to reduced educational and employment opportunities which only exacerbates the socioeconomic divides.
- 46. I saw it firsthand with students that were unable to get reliable Internet during distance-learning last year. It's an extreme disservice to students when they don't have the opportunities to perform at their best.
- 47. That I can not answer.
- 48. Many locations with in the county only have access to satellite, if that. Which does not come cheap
- 49. Our direct neighbors have access to high speed internet. We were told by the same company it would cost \$8000 to provide us the same service due to our distance from the service box. Everyone at the end of our road can get high speed internet. Unfortunately not even satellite internet providers can offer us services due to the positioning of the trees in relation to their service towers
- 50. People living out of town do not have equal opportunity to education in our pandemic world. This has affected our family personally.
